Western Australia Cat Act 2011 requires that:

- All cats must be microchipped and sterilised, unless exempt under the Act.
- You must provide proof of the cat being sterilised and microchipped i.e. sterilisation certificate or itemised vet bill.
- You must inform the city immediately of any change in ownership, the death of your cat or any change of address.
- Penalties apply for failing to renew your cat(s) registration.

If you move to another district, you are required to notify and register the pet with the new local government; however, no further fee is payable for that registration period. If you are moving interstate please check with the appropriate state/territory.
