### Western Australia Dog Act 1976 requires that:

- Dogs three months of age and over must be registered.
- Penalties apply for failing to renew your dog(s) registration.
- The owner of a dog over three months of age must ensure that the dog is microchipped.
- You must provide proof of the dog being sterilised and microchipped, i.e. sterilisation certificate, itemised vet bill.
- You must inform the city immediately of any change in ownership, the death of your dog or any change of address.

If you move to another district, you are required to notify and register the pet with the new Local Government; however, no further fee is payable for that registration period. If you are moving interstate please check with the appropriate state/territory.
